An At-Sea and/or Dockside/Roving monitor:

- (i) Must not have a direct or indirect interest (financial or otherwise) in the New England multispecies groundfish fishery, managed under Federal regulations, including, but not limited to:
 - a. any ownership, mortgage holder, or other secured interest in a vessel or processor involved in the catching, taking, harvesting or processing of groundfish,
 - b. any business selling supplies or services to any vessel or processor in the groundfish fishery,
 - c. any business purchasing raw or processed products from any vessel or processor in the groundfish fishery,
 - d. any groundfish sector or sector manager,
 - e. advocacy groups, or
 - f. research institutions.
- (ii) Must not have any immediate family members (i.e. spouse, parent, child, or siblings) with a direct or indirect interest in the New England multispecies groundfish fishery, as defined above (a-d);
- (iii) Must perform ones duties as an At-sea monitor and/or Dockside Monitor without regard to any preference by representatives of vessels;
- (iv) Must not solicit or accept, directly or indirectly, any gratuity, gift, favor, entertainment, loan, or anything of monetary value from anyone who conducts fishing or fishing related activities

- (v) that are regulated by NMFS, or who has interests that may be substantially affected by the performance or nonperformance of the official duties of an At-Sea and/or Dockside/Roving Monitor; and
- (vi) Must not, in any way, misuse his/her position, including, but not limited to improper use or disclosure of information, aiding in a known violation, or falsification of data or failure to report complete and accurate data.
